## 2017-18 AWARD RECIPIENTS

Basketball



**Elle Ruffridge**  
Pocahontas Area

Former Pocahontas Area High School standout Elle Ruffridge was the recipient of the 2018 Jack North Basketball Award.

Elle led Pocahontas Area to its second-straight Class 3A State Title. She averaged 27 points a game and set a state tournament record when she scored 48 points in the state semifinals against Center Point-Urbana. The state's career scoring and assists leader was named captain of the 3A All-Tournament Team for the third-consecutive year. Elle also received the Miss Iowa Basketball award.

Elle continued her basketball career at Missouri State University where she played in all 33 games as a freshman, averaging 3.2 points and 1.8 funds in 13.5 minutes per contest.

**Nicole Timmons**  
Davenport Assumption

Former Davenport Assumption star Nicole Timmons was the recipient of the 2018 Jack North Softball Award.

Timmons was dazzling in pitching Davenport Assumption to its first state championship in 2017. She recorded three wins while allowing just six total hits. She struck out 41 batters in three games, including 20 in the Knights' victory over Albia in the 3A state championship game.

Nicole was a key piece to Drake University's record-breaking softball season last spring. She collected a 14-4 record on the mound and was named the Missouri Valley Conference second team all-conference.

First Lady Award



**Lisa Bluder**

Lisa Bluder was chosen as the First Lady Award recipient.

The former Lisa Geske starred in the six-player game at Linn-Mar High School and continued on to play basketball at UNI. From Cedar Falls Bluder transitioned into the coaching ranks by being named the head women's basketball coach at St. Ambrose University. She quickly turned the Queen Bees into an NAIA power, reaching four straight national tournaments and two NAIA Final Fours.

In 2000, the University of Iowa named Bluder as its fifth head women's basketball coach. In 18 seasons, she has become the school's all-time winningest coach with over 350 career wins at Iowa and owns more than 700 wins in her 33-year career. She has guided the Hawkeyes to eight NCAA Tournament trips, including a Sweet Sixteen appearance in 2015. Bluder has been Big Ten Coach of the Year three times while earning regional coach of the year honors twice.

Bluder has served terms on the Women's Basketball Coaches Association (WBCA) Board of Directors and the WBCA Kodak all-American selection committee. She has also been the Midwest Regional Advisory Committee member for the NCAA Division I Women's Basketball Championships.

The Jack North Award is given every year to the senior that receives the most votes on the all-tournament team at the State Basketball and Softball Tournament.

The First Lady Award is an award given which is given "to a daughter of Iowa – recognizing the million girls of the commonwealth who have carried the tradition and training of a sport into varied and important careers – and for singularly illustrious and most memorable accomplishments."

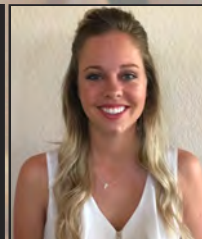

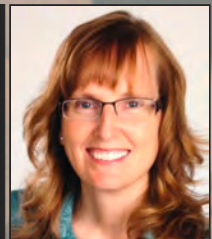

## 2018 E. WAYNE COOLEY SCHOLARSHIP RECIPIENT



Morgan Fritz, a senior from Lake Mills High School, was named the 2018 recipient of the E. Wayne Cooley Scholarship Award. Bethany was selected from 87 applicants from high schools across Iowa.

The scholarship, in the name of longtime Iowa Girls' High School Athletic Union Executive Secretary E. Wayne Cooley, is worth \$15,000 over four years to assist the recipient as she attends the Iowa college or university of her choice.

Morgan ranked first in her class at Lake Mills High School. The senior class president is active in numerous activities in school, including speech, Quiz Bowl, and marching, concert and jazz band. She is a member of NHS and FCA.

Morgan has also made a difference in her community as she created a peer tutoring program which allows middle school and high school students to get help from their peers. She is a member of the State of Iowa Youth Advisory Council which is a group that works closely with legislators on issues important to Iowa's youth.

The E. Wayne Cooley Scholarship Award was established in 1991 by the Board of Directors serving the Iowa Girls' High School Athletic Union. It pays tribute to the man who guided the Iowa Girls' High School Athletic Union from 1954 to 2002. The profile of the recipient reflects discipline, perseverance, character, superior skill, achievement and citizenship traits which personify the life and expectations of the namesake.

In the maintenance of Dr. E. Wayne Cooley's philosophy and memory, the recipient is truly a champion of her peers.

## 2018 ROBERT B. SMILEY SCHOLARSHIP RECIPIENT



Center Point-Urbana's LaMia Sisk was the 2018 recipient of the Robert B. Smiley Scholarship. While in high school, LaMia participated in basketball, soccer and track and was also involved in the National Honor Society and high school choir. She was a volunteer at youth basketball camps and a bible study leader at church. LiMia graduated with a 3.5 GPA for her high school career.

LaMia is attending Coe College in Cedar Rapids and was selected from more than 80 applicants from high schools across Iowa.

The Robert Smiley Scholarship is offered by the IGHSAU and the Smiley family in honor of longtime IGHSAU Associate Executive Secretary who passed away suddenly in 2003. There was a special place in Bob's heart for the underdog.

Bob Smiley impacted youth his entire life. He began as a teacher, coach, official and administrator in several schools throughout the state. He joined the IGHSAU in 1970 as the associate executive secretary and helped build the Girls' Union into a nationally respected leader in girls' athletics.

## 2018 CHARACTER COUNTS! COACH OF THE YEAR RECIPIENT



The 2018 recipient of the CHARACTER COUNTS! Coach of the Year was Kirk Schmaltz of Ames High School. Schmaltz has been coaching for 40 years and the last 35 at Ames High School.

Schmaltz has been the girls' cross country coach since 1983 and guided the Little Cyclone track and field team for 16 seasons. Four of his athletes captured track and cross country state championship titles under his leadership. He has won conference coach of the year seven times and regional cross country coach of the year 17 times. In 2011, the NFHS named Kirk the Regional and State Track and Field Coach of the Year.

Schmaltz has been very active in the Iowa Association of Track Coaches. He is a past-president in the organization, serving on numerous committees.

The CHARACTER COUNTS! Coach of the Year Award honors a worthy recipient who embodies the Six Pillars of Character®: Trustworthiness, Respect, Responsibility, Fairness, Caring and Citizenship. Rather than spotlight winning records and isolated acts of heroism or generosity, the award was conceived to recognize individuals whose coaching lives and achievements demonstrates an enduring commitment to any or all of the following qualities associated with good
